CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code: If the Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative declaration pursuant to CEQA. If the Planning Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption been and can be obtained determination has prepared on-line at planning.org/index.aspx?page=3447. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors, Planning Commission, Planning Department or San Francisco Public Utilities Commission at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

- a) Award Contract No. WD-2889, As-Needed Water Service Line Replacements, in the amount of \$ 26,663,850, and with a duration of 1,096 consecutive calendar days (approximately three years), to the responsible bidder that submitted the lowest responsive bid, JMB Construction, Inc., to provide as-needed traffic control, permitting, pavement excavation and restoration on streets within the City and County of San Francisco. Contractor will support 2-inch and smaller as-needed galvanized service lines renewals for the Lead Service Lead Replacement Program. (Ritchie)
- b) Accept work performed by Anvil Builders Inc for <u>Contract No. WW-687</u>, Force Main Rehabilitation at Embarcadero and Jackson, for a total contract amount of \$7,835,217, and with a total contract duration of 693 consecutive calendar days (approximately one year and 11 months); and authorize final payment to the contractor. - c) Approve an increase of 365 calendar days to the contract duration contingency for Contract
 No. WW-697, As-Needed Main Sewer Replacement No. 8, with JDB & Sons Construction, Inc.; and authorize the General Manager to approve future modifications to the contract for a total contract duration of up to 1,130 consecutive calendar days (approximately three years and one month), with no change to contract amount to allow additional time to complete all current contract work, coordinate with private development activities on Minna Street, and continue issuing contract service orders.
