- *Member Tang* asked if there is more information on the site specific feasibility analysis on solar projects of SFPUC properties. *Staff Hyams* answered, the key factors considered are the physical feasibility of buildings to support solar projects and other factors such as at the energy demand of the building, where the building is connected to the grid and the ability to provide power for CleanPowerSF customers.
- Member Tang asked what are the next steps for the Sunol site because it is a high priority site?
 Staff Hyams answered, we have some additional community engagement with the local community to determine which properties are best suited and acceptable to be used for an energy project.
- Member Garcia asked about the process of moving folks back to PG&E service.

Staff Hyams answered, CleanPowerSF as a CCA does not have the ability to disconnect a service, its presents a challenge because we need credit protections for the program. Customers that participate in a payment plan can continue in the program. It is a financial risk while being aware and balanced of the customer service aspect of this issue.

- *Member Garcia* requested that staff provide a local CleanPowerSF supply projects presentation or report from *Staff Hyams* to distribute to Power CAC members.
