- 4. Report from the Chair Wendy Aragon,
  - Chair Aragon extended a welcome to newest member of committee Anietie Ekanem. Member Ekanem is a 7 year resident of district 10, His is owner of a marketing/consulting firm and wants to increase community awareness of what the San Francisco Public Utilities Commision (SFPUC) does.
  - The Wastewater subcommittee took an urban watershed walking tour to learn about the agency's green infrastructure program in its October meeting. Chair Aragon would like to do more tours like it in the future.
  - Chair Aragon: Do we know when another one might be in the works? Staff Member Zhu: They are currently developing a series of walking tours and encourage feedback from CAC members. Wastewater Subcommittee will debrief the walking tour at the December 6 meeting and can talk about next steps in how the urban watershed management program can partner with the wastewater CAC subcommittee moving forward.
  - The SFPUC Commission passed a resolution similar the one passed by the CAC supporting the community recommendations on the Southeast Community Facility and Greenhouses.
  - Update On the Balboa Reservoir CAC (BRCAC)
    - Member Lee The Request for Qualifications (RFQ) has been issued.
    - ii. Resident Alvin Ja asked if any amount of below market housing could justify the privatization of this public land. The Mayor's office target was for 50 – 100% of the housing to be below market rate but the opinion was not unanimously supported by the Balboa Reservoir CAC.

### Topics of Discussion:

- Member O'Donnell: Is the Mountain Tunnell leadking? Is there an estimate of current water loss in the tunnel due to leaking? AGM Richie: We are leaking a little bit of water as opposed to actually losing any.
- Member Kott: Is any of the funding for this project or any other of the water projects depend on federal funding?

- AGM Richie: No federal money is being used. WSIP is paid for by ratepayer funds and some state grants.
- Member Loewenberg: Why was the condition of the tunnel not already addressed since we have known there were problems since 1989?
  - AGM Richie: In 1989 we knew there were problems with the lining in the tunnel. At the same time, the risk of seismic failure of other water facilities has far exceeded the risk associated with Mountain Tunnel. It was a matter of priorities to decide to prioritize seismic retrofit in WSIP first before addressing Mountain Tunnel.
- Member Loewenberg: This tunnel carries 85% of water from Hetch Hetchy, which if failed would be catastrophic.
   AGM Richie: Irvington tunnel carries 95% of water, so that came to the top of the priority list first. This Mountain Tunnel is a problem, but it was not as high of a priority as the seismic retrofits for Bay Division Pipelines 1 and 2. Now that we have dealt with these other serious risks, we are now addressing Mountain Tunnel.
- Member Loewenberg: What is the estimate of time to shore up the Mountain Tunnel project? AGM Richie: The plan is to do initial repairs while tunnel is closed this time around and then doing additional repairs in late 2018. Improving the adits and access is key to allowing us to fix any future problems quickly. It will probably take 5 years to go through the complete design and review process.

#### Public Comments:

- Amy Nagengast: How big is the conduit? How big is the tunnel?
   AGM Richie: The tunnel is 14 foot diameter.
- Nagengast: Do we use robots to do the inspections?
   AGM Richie: No, this tunnel we have to dewater completely so we can assess and scrutinize the state of the rock to get detailed information about the state of the tunnel.
- Nagengast: Are we considering using Remotely Operated Vehicle (ROV) to help inspect tunnel?
   AGM Richie: We used ROV to inspect the bay tunnel. However, all the experts agree that direct human inspection is necessary and far superior for the Mountain Tunnel inspection.
