- New staff introduced themselves: Todd Elmer, Director of Communications, Tyler Gamble, Deputy Director of Communications and Jay Kairam, Deputy Assistant General Manager of External Affairs.
- Staff informed CAC members that later this year, SFPUC will be reaching out to a number of organizations that members are affiliated with regarding scheduling a presentation on the water and sewer rates in early 2018.

Topics of Discussion:

- Member Loewenberg scrutinized the flooding program's funding model, claiming the benefits were shared by non-ratepayers. Stefani justified the funding by referring to the Flood Resilience Study, presented to the CAC in 2016, which illustrated that property damage is the greatest economic impact of flooding, so the benefit of reducing flooding is primarily for property owners i.e. ratepayers.
- The committee asked where the funding for the grants come from.
 Stefani informed its source to be from the Wastewater Operating Budget.
- The committee asked if property owners are aware if they are in a flooding zone and the cost of a valve installation. Stefani informed that these flooding maps are not currently finalized, but once done, the agency seeks to make the maps publicly available. Due to flooding in the recent years, property owners are aware of the risk. The unit cost for an installed valve is roughly \$2500, but the cost can vary widely from site to site depending on the plumbing configuration and interior finish materials.
- The committee referred to a past Rate Study presentation to the CAC and asked if the agency will recover some of its costs from charging customers for their stormwater contribution that burdens the sewer system i.e. parking lots. Stefani clarified that there is still a Stormwater fee planned for future rates.
- The committee asked whether flood maps would require property owners to have insurance similar to federal requirements in FEMA flood plains. Stefani informed that FEMA's federal status can use mortgage approval as a trigger to require flood insurance in flood prone areas, but PUC has no such trigger. However, individual lenders could require flood insurance using the flood maps. Flood insurance in areas that are not designated as FEMA flood zones is relatively inexpensive.
- The committee asked how applying for backflow prevention device for HOAs would work. Stefani clarified that it is per property owner e.g. in an apartment building, the landlord of the property would be responsible. In a condo, each property owner would be responsible for applying for funding for a backflow prevention device, and for a communal space the HOA would apply.
- The committee expressed concern for low income areas e.g. Islas
 Creek, that would not be able to afford flooding insurance. Stefani
 reassured that equity is being integrated into all aspects of flood
 resilience programs. The Mayor specifically inquired about using the
 Utility User Fee to fund flood insurance premiums for low income.
- Member O'Donnell scrutinized the presentation for not including incentives to divert stormwater from the system i.e. rain catchment systems and impermeable sidewalks. He suggested that the agency improve its rain catchment system incentives. Stefani informed that the presentation was intentionally focused on flooding and suggested attending the WWE Committee meeting in November for an in depth presentation on the collection system and stormwater management. Green Infrastructure can manage stormwater well in a small storm, but can be very costly to design for storms large enough to cause flooding.

- Chair Aragon asked what steps are needed for publicly owned power.
 Emily explained that the interconnection operation is a costly issue even just for municipal owned building to be powered by the agency.
 - The committee pointed out that the Interconnection Operations are affecting ambulance deployment.
- Member Kinsey asked what the policy resolution would be to resolve the interconnection operation challenges. Emily informed there is limited information. Vacancies on FERC and thus inaction at FERC have meant the agency is operating under a lot of uncertainty. However public support is a good start.
- Member Sandkulla requested more information on the interconnection operation, ideally a more in depth presentation, so that the committee can learn how to better support the PUC.

Public Comment:

 Michael Sizemore asked if the agency is considering deploying off-grid solutions and if there were any public comment on SB-649 regarding a delay in renewable energy plans. He also suggested that the presentation include the impacts of the interconnection operations on Treasure Island.
