

## WATER SYSTEM IMPROVEMENT PROJECT **Regional Groundwater Well Site in South San Francisco**

When: JMB Construction, the contractor for the San Francisco Public Utilities Commission, is anticipated to begin mobilizing the week of June 30, 2025 with completion anticipated by March 2027. Weather and construction issues could impact the schedule. General workdays and hours (weather permitting) are Monday – Friday, 8:00 a.m. to 5:00 p.m. Some night and weekend work may be required, especially along Chestnut Avenue in South San Francisco.

Where: Water work will occur from the well site at 951 Antoinette Lane, South San Francisco, along El Camino Real to Chestnut Avenue and along Chestnut Avenue to the Cal Water site.

Why: The objective of the project is to transport groundwater from SFPUC South San Francisco (SSF) Main Well to California Water Service Company (Cal Water) Treatment Station in South San Francisco. The project will make improvements at the existing well site which includes mechanical, electrical, structural, and corrosion protection upgrades. The work is to be performed in South San Francisco, California.

What to expect during construction: Water main installation is done in phases, so work will not be happening on your block for the entire project duration. There may also be periods of inactivity during the work dates. Local access for residents will be provided at all times during work hours, though there may be some slight delay to enter or exit your property/driveway to allow for crews to create a safe path of travel.



Contractor will place "no parking signs" on street where construction will take place 72 hours in advance per San Francisco Municipal code. Parking is prohibited in the work zone only during construction hours.



Contractor will excavate a trench where new water main pipe is to be installed. There will be noise, vibration, dust, parking and traffic impacts in the work zone and some disruption to normal neighborhood activity.



Contractor will install pipe and refill the trench with special materials to protect the pipe. The contractor will temporarily pave the excavated area and return at a later date for the final paving. Temporary paving could be in place for weeks or even months on larger projects.



SF Water Department will connect new water main pipe to properties. This will involve a temporary interruption of water service. Crews will provide advance notice a minimum of 24 hours.



Once the entire project has been completed, final paving is performed. All equipment and materials are removed from street.


