WATER SYSTEM IMPROVEMENT PROJECT

Millbrae Campus Fencing and Security Upgrades

When: Rodan Builders, the contractor for the San Francisco Public Utilities Commission, is anticipated to begin mobilizing the week of August 25, 2025 with completion anticipated by Fall 2026. Weather and construction issues could impact the schedule. General workdays and hours (weather permitting) are Monday – Friday, 7:00 a.m. to 3:30 p.m. Some night and weekend work may be required.

Where: Upgrading the fencing, adding a retaining wall, and new security measures are totally within the Millbrae Campus at 1000 El Camino Real, Millbrae, CA. The fencing work will be integrated with the adjacent property owners, including CalTrain, and the El Rancho Inn.

Why: The objective of the project is to secure the campus and buildings as well as the parking lots, underground pipelines and water distribution system. The work is to be performed in Millbrae, California.



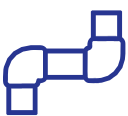
Contractor will place “no parking signs” on areas nearby where construction will take place. Parking is prohibited in the work zone only during construction hours.



Contractor will clear any vines or other overgrowth and remove existing fencing that is in poor condition or damaged. Fencing that is still in good condition will remain in place. There will be noise, vibration, dust, parking and traffic impacts in the work zone and some disruption to normal neighborhood activity.



Contractor will prepare the area and begin installation of the new perimeter fencing and gate assemblies. There will be a new cantilevered gate to secure the shop/yard area during working hours. Also there will be new access controls and alarm monitoring systems, card readers, plus a new digital video surveillance system with high resolution digital cameras.



Once the new fencing and upgraded security systems are installed, they will be tested and approved. In addition, any roadways or parking areas needing to be graded or paved will be restored to proper condition. Landscaping will be installed throughout the area as needed to enhance the new fencing, gates and garden.



Once the entire project has been completed, any final grading, walkways or paving is performed. All equipment and materials are removed from the campus.

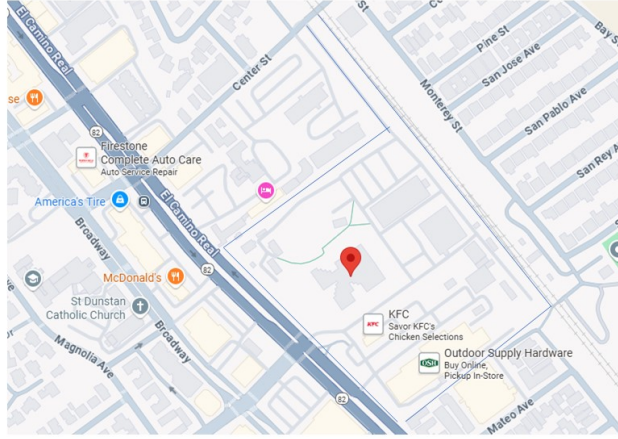
