

WATER SYSTEM IMPROVEMENT PROJECT

Pipeline Replacement at Sunol Glen School & Arroyo de la Laguna

When: Construction is anticipated to begin in May 2025 with completion anticipated by October 2026. Weather and construction issues could impact the schedule. General workdays and hours (weather permitting) are Monday – Friday, 7:00 a.m. to 5:00 p.m. Night and weekend work are not anticipated but may be required.

Where: Work will occur from the Pleasanton Sunol Road gates near Niles Canyon Road and extend below the creek and under the Sunol Glen School athletic field, terminating in the school parking lot.

What: 12-inch ductile iron water main replacement, followed by restoration of creek habitat and school athletic field.

Why: We are replacing aging pipeline at the end of its useful life to ensure reliable water service to the Town of Sunol for drinking water and fire suppression, and removing the risk of it being ruptured where exposed above the creek.

What to expect during construction: Water main installation is done in phases, so there may be periods of inactivity during the work dates. Work on the school grounds is planned for the summer when school is not in session. Roads in the area will remain open during work hours. Construction vehicles will generally use our entrance on Pleasanton Sunol Road.



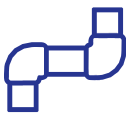
Contractor will place “no parking signs” 72 hours in advance should it be required for safe entry and exit of construction vehicles. Parking would only be prohibited in the work zone during construction hours.



Contractor will excavate a trench under the creek and through the athletic field where the new water main pipe is to be installed. There will be noise, vibration, and dust, with only minor disruption to normal neighborhood activity. Portions of the school’s athletic field will be closed off during construction.



Contractor will install pipe and refill the trench with special materials to protect the pipe. The contractor will ensure that the riparian habitat along the creek is protected from disruption.



A temporary bypass will be installed to maintain water service to the Town during construction. There will be a brief water shutdown during the initial installation and again during final removal of this temporary water line. We will provide 24-hour advanced notice before any shutdowns occur.



Once the entire project has been completed, both the Sunol Glen School athletic field and the Arroyo creek bed will be restored to their previous condition. All equipment and materials are removed from the project area.
