

## **Making Upgrades**

## 30-Day Construction Notice – Various Locations Brick Sewer Improvements Rehabilitation Project

**Description:** As part of the Sewer System Improvement Program, the San Francisco Public Utilities Commission (SFPUC) contractor, Cratus Inc., will begin construction to rehabilitate the existing 100-year-old sewer pipelines and replace some lower sewer laterals, if needed, in the project area (street locations listed below and pictured in the following page).

When: The anticipated start of construction is early 2023, and anticipated completion is in late 2023/early 2024. Weather and construction issues could impact the schedule. General workdays and hours are Monday – Friday, 7:00 a.m. to 5:00 p.m. Some night and weekend work will be required.

Where: This work will occur in the locations listed below and pictured in the map in the following page. Expect delays, consider alternate routes, and plan ahead if you must travel through the area.

- a. Montgomery & Vallejo Street intersection
- b. Montgomery Street, between Broadway and Pacific Avenues
- c. Commercial Street, between Grant Avenue and Montgomery Street
- d. Kearny Street, between Clay and Sacramento Streets
- e. Columbus Avenue, between Greenwich and Filbert Streets
- f. Powell Street, between Greenwich and Filbert Streets
- g. Union Street, between Powell Street and Columbus Avenue
- h. Powell Street, between Union and Green Streets
- i. Powell Street, between Pacific Avenue and Jackson Street
- j. Leavenworth Street, between California and Bush Streets
- k. Hyde Street, between California and Pine Streets
- I. Franklin Street, between Union and Green Streets
- m. Geary Boulevard, between Van Ness Avenue and Polk Street
- n. Golden Gate Avenue and Hyde Street intersection
- o. Eddy Street, between Mason and Cyril Magnin Streets

## Additional Notice will be Provided:

Due to the extensive number of locations where upgrades are planned, <u>additional 10-Day notice</u> <u>will be provided</u> prior to work starting at each location.

## What to Expect:

- CURED-IN-PLACE PIPE: To minimize impacts to the roadway and adjacent residences and businesses, much of
  the sewer rehabilitation work will use a trenchless method called <u>Cured-In-Place-Pipe (CIPP)</u>. In some
  locations, street excavation may be required, and advanced notice will be provided.
- SEWER SERVICE: These services will NOT be interrupted during construction.
- PARKING: Street parking will be impacted near construction zones. "No-parking" signs will be posted 72 hours in advance.
- TRAFFIC: Partial and/or full lane closures may be necessary to ensure safety of workers and the public. Advance notice and detour signage will be provided, as needed.
- MUNI: Bus stops may be impacted during work, and if so, advance notice will be provided.
- ACCESS: Follow posted signage on site. Businesses and residents in the work zone will maintain access to their driveways and entrances during construction.
- NOISE: Neighbors may hear construction noise periodically. Noisy work will be conducted in compliance with the San Francisco Noise Ordinance.
- ODORS: If necessary, odor control measures will be in place during construction.
- NOTICE: Residents and businesses within the project area will be notified before construction begins.
