This ordinance assures that deliberations are conducted before the people and that City operations are open to the people’s review.

The meeting room is wheelchair accessible. There is accessible parking available in the Southeast Community Facility parking lot and ample off-street parking on Oakdale and Phelps Streets. Providing at least 72 hours notice will help to ensure availability.
