#### Discussion

- **Member Nagengast** asked what is the goal for 2025 in terms of biosolids use in land application?
  - **Staff Fischer** answered the goal would to maximize the potential benefits biosolids provide to soil. That would be reflected in be 100% of biosolids use in direct land application. Another goal would be addressing public concern and answering questions from the public and state regulatory agencies.
- Member Aragon asked, it was mentioned that there is no evidence that human waste as a route for COVID-19 infection, is this a major concern from the public?

**Staff Batjiaka** answered, we have received only one inquiry on if wastewater is a form of infection. Additionally, we are working to develop testing to track trends in cases within a service area. As testing and methodology becomes more consistent we can develop ways test RNA (i.e. proteins) of COVID-19 in wastewater.

- Chair McKinney suggested that the factsheet to include link to the EIR and Environmental Justice analysis so the reader can find more in depth information on this air monitoring project.
  Member Argon added, that helpful for the factsheet to avoid being overly technical in order to provide accessibility to the public while offering a way for the reader to access more information if desired.
- Member Nagengast suggested sharing this factsheet with community groups who are participating in air monitoring and the Southeast Community Facilitate commission.
