Discussion Topics:

- *Member Ekanem* asked if the operation construction and the treatment plant emissions were being reported out to the community. *Staff Meei-Lih* responded that she can speak to the process of air monitoring but is unable to speak to how the information is distributed to the community.
- *Member Ekanem* stated that although constructions emissions are different from the treatment plant emission, the community is unable to determine the difference between them both, which bring the urgency to report on combined emissions.

Staff Colwick responded that he is unable to respond at the moment but would like to take the concerns back to their team to ensure they look at the totality of emissions.

- *Member Ekanem* asked if there are any hotlines available to the public or factsheets to inform the public on emissions levels and odors. *Staff Colwick* responded that 311 is available to report odors.
- Member Ekanem asked about the response rate for staff to respond to a 311 incident report.

Staff Meei-Lih responded that the time response time is relatively quickly.

• *Member Loewenberg* asked if there was a network of air quality sensors that help determine the emissions that are being emitted from the facility and entering people's homes.

Staff Meei-Lih responded that they don't monitor air quality beyond the the fence line of the Treatment Plant, however, they do have an air dispersal model that does provide an estimate of air quality.

 Member Loewenberg wanted to confirm that the air leaving the treatment plant is not tested and that algorithms are being utilized to provide estimates.

Staff Revilla responded yes.

• *Member Nagengast* commented and suggested that in light of the SFPUC Environmental Justice Policy Anniversary when thinking about permits, it is important to drive towards opportunties to reduce the

emissions at the facility in order to lessen the environmental burden in neighboring communities.

Staff Meei-Lih responded that the Sewer System Improvement Project has more stringent targets than what the permits allow them.

- *Member Nagengast* commented that the resolution feels too vague and suggested to add more specificity.
- *Member Loewenberg* also agreed that the resolution seems vague and does not have an action item.
- *Member Ekanem* asked if there were any specific projects currently being delayed by PG&E that the Citizens' Advisory Committee can highlight in the resolution. *Member Tang* responded that a quarterly report is being released listing all of the projects being delayed.
- *Member Loewenberg* commented that a key topic that is missing in the resolution is the reason why the acquisition is important to the City and County of San Francisco and that the bankruptcy itself can cause PG&E to go away.
- *Member Tang* stated that he would revise the resolution to incorporate the feedback and will bring it back to the full Citizens' Advisory Committee.

Public Comment:

- Public member Nate Kinsey suggested that the resolution should clarify the interconnection agreement. Kinsey also suggested to include the total number of projects that have been delayed, local control in decision making, and to consider the idea purchasing of PG&E assets as a Prop A Bond.
